A vertical tasting of "14" vintages of Delheim Grand Reserve

### Toronto Lawn Tennis Club Thursday, Sept 17, 6:30 pm



Delheim's origins as a wine estate go back to the 1930s when purwas chased by Hans Otto Hohsenhein and his wife Deli

(hence 'Delheim', for 'Deli's home'). In 1951 their nephew Spatz Sperling moved from Germany to help out with the estate. In 1957 the property was turned over to Spatz on a profit-sharing basis. Subsequent acquisitions have expanded the vineyard area to an impressive 170 ha.

Spatz Sperling has been actively involved with the general management of the business. Vera, his wife, is involved with architectural activities such as decor and layouts. Daughter Nora Sperling-Thiel handles export marketing. **Victor** is the viticulturist, and also involved with the general management of the farm. The other two children, Maria & Nicholas live in Amsterdam.

As General Manager and Viticulturist Victor Sperling's latest project is an organic waste-water recycling system. Through a series of bio-reactors and an indigenous wetland, Delheim are able to re-introduce the waste-water from their cellar and restaurant, back into the environment from which they took it.

**Victor**, studied in California and Germany and now manages the estate with sister Nora, who has been a regular visitor to our club. He will present an impressive array of vintages of **Delheim's Grand Reserve**, a cabernet sauvignon, sometimes blended with other varietals. It has been rated 4\* or higher for 20+ years.

Follow the progress over the years and be impressed by the overall quality. This "world exclusive" tasting of **fourteen** vintages of their flagship **Delheim Grand Reserve** is only possible with the support of Delheim and their wine library.

A tasting plate will be served.
